INSTRUMENT OF DELEGATION

DEL 2025/03 Powers of Officers (Department of Transport (Maritime matters))

Delegation to officers of certain functions of the Western Australian Planning Commission, under the Metropolitan Region Scheme (MRS) Greater Bunbury Region Scheme (GBRS) or Peel Region Scheme (PRS)

Preamble

Under section 16 of the Planning and Development Act 2005 (the Act) the Western Australian Planning Commission (the WAPC) may, by resolution published on a website maintained by, or on behalf of, the WAPC, delegate any function to a member, committee or officer of the WAPC or to a public authority or a member or officer of a public authority.

In accordance with section 16 (4) of the Act, a reference in this instrument to a function or power of the WAPC includes and extends to, without limitation or restriction, any of the powers, privileges, authorities, discretions, duties and responsibilities vested in or conferred on the WAPC by the Act or any other written law as the case requires.

Resolution under section 16 of the Act (delegation)

On 22 JANUARY 2025 pursuant to section 16 of the Act, the WAPC resolved -

- A. TO REVOKE its delegation of powers and functions to person or persons as detailed in the instrument of delegation 'DEL 2021/04 Powers of Officers (Department of Transport (Maritime matters)) as published in the Government Gazette on 18 January 2022
- B. To DELEGATE its powers and functions as set out in column 1 of Schedule 1, to the person or persons from time to time holding or acting in the offices in the Department of Transport, as specified in column 2 of Schedule 1, subject to the conditions specified in column 3 of Schedule 1 and the requirements in Schedule 2.

Schedule 2

- 1. The officer performing these powers and functions shall provide bi-annual reports to the WAPC, in a format prescribed by the WAPC.
- 2. The reports provided under point 1 above shall detail the number of applications received in that period, the type of development applied for and the decision made on each application.
- 3. The reporting period shall commence on the date of gazettal of this instrument, with the first report due no later than 6 months after gazettal.

Interpretation

A position listed in this instrument contemplates and includes its successor in title.
